#### Daily Berth in Sea / Land includes:

- Berth, use of toilet facilities and showers and water consumption (washing of vessels not included), Wi-Fi Internet.  
For vessels which sail into the marina in the period between 7 am (when the reception desk opens) and 12am of the same day, the daily sea berth fee covers the stay in the marina until 2 pm on the following day. For vessels which sail into the marina at night, in the period between 12 am and 7 am, the daily berth expires at 2 pm on the same day. After 2 pm the berth is charged for the following day. For a short stay in the marina (less than 4 hours), the price of the daily sea / berth is reduced by 50%.

#### Yearly Sea / Dry Berth includes:

- Sea or dry berth, monitoring of the vessel, use of toilet facilities and shower, and water consumption (washing of vessels not included), one parking space in the marina parking for the vehicle of the vessel owner indicated in the yearly contract, Wi-Fi Internet, wellness center. Yearly dry berth includes vessel platform. Washing of the underwater part of the vessel is not included in the price.

#### Monthly Sea / Dry Berth includes:

- Sea or dry berth, monitoring of the vessel, use of toilet facilities and shower, water consumption (washing of vessels not included), Wi-Fi Internet.

Notes: The service is offered subject to availability. Pedestal and underwater washing of the boat is not included in the price.

Supplement for accommodation on land (with the signed contract on the annual connection at sea):

- The price of the annual berth at sea is increased by 25% for accommodation on land in the period from 01.09. to 28.02. Accommodation includes: boat supervision, use of toilets and showers, use of the Internet.

Keeping the boat on the travel elevator is charged as 1 operation, and the price is additionally increased by 100,00 € EUR per hour for use of max 3 hours.

The relocation of the vessel on land, at the request of the owner is charged as one operation of the travel lift.

The user is obliged to lower the sails before raising the vessel ashore, otherwise the service will be charged in accordance with the used working hours from the marina price list.

The service of divers during the use of the travel elevator is charged according to the working hours of the divers, depending on the hours actually spent.

The maximum width of the vessel for the use of the travel lift is 7,00 € m.

#### **GENERAL CONDITIONS AND NOTES:**

The price list is effective from January 1, 2024. Marina Nautica reserves the right to change and update the price list without prior notice, as well as errors in printing.

All users of Marina Nautica services are obliged to comply with the Terms from the valid price list of Marina Nautica, the General Terms and Conditions for concluding contracts and the Ordinance on order in the port of Marina Nautica. In case of non-compliance, Marina Nautica may cancel the right to use the berth.

All these services are paid at the time of execution / delivery, except for those whose method of payment is defined in the contract.

The book of complaints are at the reception.

Marina Nautica reserves the right to charge for berths in accordance with the project documentation, is according to the actual length of the berth used, and not according to the length of the vessel.

#### **Waste disposal:**

Marina Nautica will, in accordance with Art. 77 of the Ordinance on the conditions and manner of maintaining order in ports and other parts of the internal sea waters and territorial sea of the Republic of Croatia (OG 72/2021) and the Ordinance on order in the port of Marina Nautica to collect indirect fees for:

- Yachts and boats that have concluded a nautical berth contract pay an indirect fee for the acceptance of waste, regardless of the actual delivery of waste in a lump sum of 1% of the fee charged by Marina Nautica under the berth agreement.
- Yachts and boats, when in transit, pay an indirect fee for accepting waste when entering a port other than the port where they have a contracted nautical berth, regardless of the actual delivery of waste in a lump sum of 1% of the berth price

#### **Electricity consumption:**

All moorings have an electricity connection in accordance with the size of the vessel (from 16A to 63A). Marina Nautica will collect the fee for the use of electricity to the User as follows:

- The user who has concluded a contract on a nautical mooring pays a fee for electricity consumption in a flat amount equal to 6% of the price of the mooring charged by Marina Nautica based on the mooring contract and the valid price list.
- For a user who has concluded a contract on a nautical connection, and whose vessel is staying at the A pier, the electricity consumption will be calculated according to the actual consumption and charged according to the valid price list.

#### **Water consumption:**

Normal water consumption (excluding boat washing) for all vessels is included in the price of daily, monthly, seasonal and annual sea / land berth.

Consumption of water for the supply of a larger amount of water (over 200 liters per day) is charged according to the current price list of other services of Marina Nautica.

When washing the boat, the use of manual water regulators, so-called water guns, is mandatory.

#### **Prices:**

This price list includes the prices of sea berths, accommodation of vessels on land, and other services. The service is charged based on the length of the vessel over everything (l.o.a) and the width of the vessel. Marina Nautica reserves the right to check the length and width of the vessel. In the event of a discrepancy in the dimensions of the vessel, Marina Nautica reserves the right to calculate the price according to the survey determined by the actual dimensions (length over all - l.o.a.)

#### **Catamarans and trimarans:**

For catamarans and trimarans, all prices of berths, accommodation and other services are increased by 100%.

#### **Auxiliary vessels:**

Auxiliary vessels, whether subject to registration or vignette marking, do not pay for the berth when they are on the parent vessel. The user of the Agreement on the use of annual or monthly berth at sea / on land is obliged to conclude a berth agreement for an auxiliary vessel using a separate berth, and the price of annual, monthly or daily berth at sea or on land is charged with 50% discount 9,99m and for larger category vessels the full price of the berth is paid. When the auxiliary vessel uses a separate berth, and the parent vessel is not

in the mode of contractual berth, but only in transit, the daily berth for the auxiliary vessel is charged in accordance with the valid price list. The service is offered depending on the availability of capacity.
